## **FINANCE**

### 5 Year Tax Abatement Bills

The Township offers eligible properties a 5-year phased-in tax abatement program. The abatement is applied to the structure, be it either new structures or additions to existing structures. The first year, property owners will pay no tax on the structure, with each following year being billed by the Finance Office at 20% increasing increments (20%, 40%, 60% & 80%) of taxes that would be paid if no abatement was in place. It is important to note that the abatement applies to the structure only and not the land. A separate bill for the land taxes will be sent by the Tax Collectors office for the 5-year abatement period. At the conclusion of the 5-year abatement period, the two bills will permanently be merged into the Tax Collectors bill that will reflect the full taxes due for the land and structure going forward. Information on meeting criteria for abatement eligibility can be obtained from the Tax Assessors Office.

## **Grants and Capital Projects**

The Township has always been aggressive in its attempts to obtain grants to fund various projects in an effort to reduce the burden on the local budget. In addition to the grants routinely received for various Police and Public Works functions which total approximately \$175,000 annually, several Grants have been awarded that provided improvements to Carmelo Felix Park, Volpa Park, Calabrese Park and Donio Park. Grants have also been received for Opioid Drug Awareness and Abuse Prevention.

The Township uses its capital budget not only for the purchase of vehicles and equipment necessary to the operations of the Township, but also to supplement grants and fund additional projects such as improvements to Hegan, Albion, Iuliucci and Sirolli Parks.

## **CODE ENFORCEMENT**

Winslow Township Code Enforcement Department focuses on Neighborhood Preservation. The Property Maintenance Code is an essential part of maintaining the appearance and integrity of Winslow Township. This code holds property owners responsible for the upkeep of their properties. The main goal of the code enforcement program is to bring to the attention of residential and business owners any existing code violations that could have a negative impact on their property, neighborhood, and the community.

Code Enforcement is implemented on a complaint driven basis and through routine and proactive enforcement of municipal ordinances.

**Littering** - Littering in public or private places (including common area in communities that have HOA) is prohibited. No person shall throw, deposit, or dump any garbage, litter, refuse, rubbish, solid waste or other waste material on any street or sidewalk or any public or private premises, whether vacant or not, except in public or private receptacles for the collection of such materials. No person shall use any private receptacle which is owned or rented by another without the express permission of the person who owns or rents the private receptacle.

**Disturbing Noise Prohibited** - It shall be unlawful for any person to make, continue or cause to be made or continued any loud, unnecessary, or unusual noise or any noise which either annoys, disturbs, injures, or endangers the comfort, repose, health, peace, or safety of others within the limits of the township. The following acts are hereby declared to be examples of loud, disturbing and unnecessary noise in violation of this section: using, operating or permitting to be played, used or operated any radio, receiving set, television, musical instrument, phonograph or other machine or device for the producing or reproducing of sound in such manner as to disturb the peace, quiet and comfort of the neighboring inhabitants or with louder volume than is necessary for convenient hearing for the person or persons who are in the room, vehicle or chamber.

**Sidewalk Maintenance** - Whenever the pavement or surface of any public sidewalk or portion thereof upon or along a public street or highway in the township shall be found to be broken, disintegrated, uneven or otherwise defective to such an extent that it would be likely to cause a pedestrian to trip or fall in passing along the same, it shall be the responsibility of the abutting property owner to make

the necessary repair and/or reconstruction of the sidewalk or portion thereof.

**Motor Driven Vehicle** - Includes but is not expressly limited to minibikes, motor scooters, go-carts, all-terrain vehicles (ATV's), swamp buggies and snowmobiles and any other motor-driven vehicle not capable of being registered under N.J.S.A. 39:1-1 et seq., as amended, Motor Vehicles and Traffic Regulations, of the New Jersey Statutes, as amended, except such vehicles in N.J.S.A. 39:1-1 et seq., as amended, which are expressly exempt from registration.

No person shall operate, or permit and/or suffer to be operated, a motor-driven vehicle, as defined herein, except as set forth in § 274-2.1 below, within the Township under the following circumstances:

On private property of another without the prior express written permission of the owner and occupant of said property. Where such prior express written permission has been obtained, the operator shall keep the same on his person, available for immediate display during the period of such operation.

On any public, municipal or Board of Education grounds or property, including public parks, recreational areas, ball fields, tot lots, and school grounds.

On any public sidewalks or public streets or areas dedicated or commonly used for pedestrian or vehicular traffic.

On any common areas, parking areas or open space areas of any apartment, multifamily, residential, commercial, or industrial site, complex or development.

In a careless, reckless, or negligent manner to endanger or be likely to endanger the safety or property of any person or persons.

In such a manner as to create loud, unnecessary, or unusual noise to disturb or interfere with the peace and quiet of other persons and no person shall operate such motor-driven vehicle as defined herein before the hour of 9:00 a.m., prevailing time or after sunset or at any time within 500 feet of the property line of any property zoned "residential" or used for residential purposes and not owned by the operator.

Each motor-driven vehicle shall always be equipped with a muffler in good working order and no person shall use a muffler cut-out, by-pass, or similar device on said vehicle.

## **ANIMAL CONTROL**

Animal Control Winslow Township has 2 full-time Animal Control Officers who respond to a wide variety of calls. Their primary objective is public health and safety – as well as the safe and humane care of animals within Winslow Township. Winslow Township Animal Control Officers are outfitted with tablets that enable them to immediately locate whether a lost pet is licensed with the Township and if the animal is microchipped. Animal Control would like to remind residents that this department handles domestic animals. If you are having a wildlife issue, we will try to assist but, in most cases, you will need to contact a wildlife management company.

\*\*Renew your pet licenses. Your current license expired December 31, 2023. Registration of animals after March 31st will be considered late, and a \$25.00 late fee will be charged in addition to the regular license fee per animal\*\* Pet licenses can be obtained by completing the application on the township website at www.winslowtownship.com under forms and documents section.

## **Leashing Requirement:**

No person owning or having the control, custody or possession of a dog shall permit such dog to run at large or to go or be upon the public streets, sidewalks or other public places within the Township unless said dog shall be on a leash and in the custody of some person or persons capable of controlling such dog.

## Soiling or defiling property:

No person owning, keeping, or harboring any dog shall permit it to soil, defile or commit any nuisance on any place where people congregate or walk or upon any public property whatsoever. This provision shall apply to all privately owned property in the Township, except the property of the owner or keeper of the dog and the property owned or controlled by persons who have invited or permitted the owner or keeper of a dog to bring such dog upon the premises.

Winslow Township Code Enforcement and Animal Control are ready to assist! If you wish to report a non-urgent matter to Code Enforcement or Animal Control you may do so by going to the online winslowtownship.com under "Service Request "or downloading the "My Winslow" app. Should you wish to call Code Enforcement or Animal Control you may do so at (609) 567-0700 extension 7002 or email code@winslowtownship.com.

## Food/Feeding:

No person who is not a licensed owner of a dog or cat as required under Chapters 126 and 127 of the Township Code, respectively, shall place food for dogs or cats outside of his or her home. Placement of such food outside a residence without a license is prohibited.

## OFFICE OF THE MUNICIPAL CLERK

The Clerk's Office is a major source of information for our residents. The Municipal Clerk and her staff serve as a liaison between the community and the Township.

## What types of licenses does the Clerk's Office issue?

Kennel licenses, pet licenses, shooting gallery & range licenses, towing licenses, trailer court licenses, bingo/raffle licenses, business licenses, solicitor's licenses, alarm permits, yard sale permits, taxicab licenses, limousine licenses, clothing bin licenses and liquor licenses.

## Who do I contact to use a Township field or park?

The Clerk's Office issues permits for the use of Township parks and/or fields for sports teams and residents. Please note: To obtain permits for the New Brooklyn Park on Erial Road, please call 856-216-2117 or visit www.camdencounty.com/parks

## How can I get a copy of a public record?

The Municipal Clerk is responsible for and processes all Open Public Records Act (OPRA) applications. OPRA requests are responded to within seven (7) business days. Requests for public records can be emailed to clerk@winslowtownship.com

## Where can I register to vote?

The Municipal Clerk is the Administrator of Elections and forms are available to register to vote, change your address, change party affiliation and to request vote by mail ballots. You can also register online at https://voter.svrs.nj.gov/register

## Attention Business Owners!

Business owners are now required to maintain liability insurance in an amount no less than \$500,000.00 for property damage and bodily injury or death.

3. Click on "Opt into Auto Pay" in your account and follow prompts.

## Once enrolled:

- 1. Residents will receive an email at least one week prior to the payment being processed on XX/XX/XXXX. Email will contain a CONFIRMATION #.
- 2. On said date, the payment will be for the total current balance and will be deducted from your selected method of payment.
- 3. Based on timing, if a resident signed up after the schedule is defined, they may not be included in the first run directly after registering. It is the resident's responsibility to check your account balance online and personal statements to ensure the payment was successful.

## Cancelling a scheduled payment:

- 1. The notice will go out a week in advance to allow the resident time to act and make any changes or cancellation if necessary for whatever reason.
- a. If you want to cancel autopay for a single time, you will need to forward via email the CONFIRMATION # along with a statement saying you wish to cancel the upcoming autopay at least 2 days before it is scheduled to be processed. Emails should be sent to collections@ winslowtownship.com
- b. To cancel autopay entirely, residents will have to opt out in their account enrollment.


## **UTILITIES QUICK TIPS**

As the Spring and Summer Season is fast approaching, please be reminded of the following

- Mandatory Water Conservation Measures have NOT been lifted and are still in effect.
- These measures have been in effect since June 1, 2006, they are as follows:
- Odd numbered homes should water their lawns on odd numbered calendar days.
- Even numbered homes should water on even numbered calendar days.
- In addition, you may only water between the hours of 5 - 7 am and 7 - 9 pm.
- Sprinkler Zones may only run a maximum of 20 minutes per zone.
- No one may water their lawns on the 31st day of the month.
- Note: restrictions do not apply to privately owned wells.

## USEFUL TIPS, ON HOW TO SAVE WATER OUTDOORS:

- Lawn watering uses a lot of water. Water your lawn only when it
  needs it. An easy way to tell if your lawn needs water is to simply
  walk across the grass. If you leave footprints, your lawn may be
  thirsty! Generally, lawns only need an inch or so of water per
  week during the summer months. Water your lawn wisely by:
- Making the most of your watering by watering in the early morning. As much as 30 percent of water can be lost to evaporation by watering during midday.
- Planning for fewer, deep-soaking waterings to encourage deep root growth and stronger turf.
- Set your lawn mower one notch higher to make your lawn more drought-tolerant.
- Use drip irrigation hoses to water plants, and water in the early morning or evening.
- Consider using porous pavement (gravel is a good example) instead of asphalt for driveways and walkways, the rain will soak into the soil instead of running off and contributing to erosion.
- Use a broom instead of a hose to clean your sidewalk, driveway, or patio.
- Plant appropriately for your local climate. Check with local nurseries for non-invasive, drought-tolerant plants.

## Looking to Expunge your court record?

An expungement is the removal, sealing, impounding, or isolation of all records on file within any court, detention or correctional facility, law enforcement or criminal justice agency. A court-ordered expungement can remove the following information:

- All court proceedings related to your case
- · Your criminal or juvenile conviction
- The outcome of your case, including your sentence

## **CAMDEN COUNTY SURROGATE COURT SURROGATE MICHELLE GENTEK-MAYER**

The Surrogate Court was established by the New Jersey Constitution. The functions of the Surrogate's Court are established by state statutes as the court in each county responsible for certain duties and functions related to estate administration including wills, administrations, guardianships of minors and incapacitated people. The Surrogate's Court also serves as Clerk of the Court for Chancery Probate actions and Adoptions. The office has its origins in English law, where the bishop of the region would appoint a substitute, or "surrogate", to handle certain affairs. Eventually, this authority evolved from church officials to civil officials.

## Function of a Surrogate

Probate of Wills – Probate is the process whereby a Last Will and Testament is proved to be valid by the Surrogate and the Executor appointed by the Surrogate's Court

Administration – When someone dies without a Last Will and Testament, the Surrogate's Court appoints an administrator to handle the affairs of the decedent.

Guardianships - The Surrogate's Court can issue a judgment to establish a guardianship for the person or property of a minor.

Trusts – When a trust is created in a Last Will and Testament, the Surrogate appoints the named trustee to administer the trust.

Adoptions – In the adjudication of adoption matters in Camden County, the Surrogate's Court serves as the Clerk of Superior Court, maintains the files, and secures the confidentiality of the documents.

Chancery Division/Probate Part – In the adjudication of contested litigation, guardianship of Incapacitated Adults

and various other estate litigation, the Surrogate's Court serves as the Deputy Clerk of the Superior Court, Chancery Division. The Surrogate maintains a digitized file of the litigation.

Management/Investment of Minors' Funds — The Surrogate's Court receives, manages, and invests funds for minors/or Incapacitated Adults as ordered by the Superior Court. The Camden County Surrogate currently maintains over \$17 million dollars in the Surrogate Intermingled Trust Fund.

Records – The Surrogate's Court maintains a digitized database containing records of all estates probated in Camden County, guardianship actions and all Superior Court proceedings related to the office dating from 1851.

Wedding Services – Wedding ceremonies for Camden County residents are performed by Camden County Surrogate Michelle A. Gentek-Mayer. Please contact Aja Bunten at 856-225-7130 to schedule.

## Conversation of Your Life

The Conversation is the Surrogate's way to educate members of the community on the importance for advanced care planning, including powers of attorneys, living wills, the appointment of funeral agents and last will and testaments. As part of the Conversation, the Surrogate opens the floor with individuals to engage in meaningful dialogue and how to begin these discussions with their family, friends or doctors to understand and respect their end-of-life wishes.

## **ASSESSOR'S OFFICE**

## Farmland Assessment Act of 1964

Farmland applications will be sent out by our office to property owners currently receiving farmland assessment in the middle of June. Requires owners to apply **annually** for Farmland Assessment. Farmland Applications must be filed with the Tax Assessor no later than **August 1st** of the pretax year. Applications received after **August 1st** may be denied. All sections of the forms must be completed by the property owner before submitting them to our office. The assessor's office will be inspecting farms for qualifying activity over the next few months. Properties that do not meet the prerequisites may be subject to Roll-Back Taxes. For properties that do not currently have farmland assessment, it is the responsibility of the property owner to call and request an application, which is also due back **August 1st**. ## Property Tax Deduction? Do you qualify?

The State of New Jersey, administered through the Assessor's Office, provides property tax deductions to Veterans, Widows of Veterans, Senior Citizens, Disabled Persons and Widows of Seniors and Disabled Persons. Each deduction has specific qualifications/prerequisites that must be met and requires the filing of an application.

## WINSLOW TOWNSHIP FIRE DEPARTMENT

To our residents: We **THANK YOU** for all of the support you continue to show our organization to meet the needs in providing community fire and rescue protection. We continue to meet the needs of high call volume and support the community in many other ways. We are a combination Fire Department consisting of both Volunteer and Career firefighters serving the community 24/7 from 5 fire stations covering nearly 60 square miles. Along with responding to calls, the Fire Department is very engaged in the community; participating in public education/relations events, supporting many charity events and Fire Code Enforcement, along with an aggressive free smoke alarm inspection program for residents who qualify. 2023 saw the change in our deployment model with an increase of staffing at the Waterford Works Firehouse (Station 25-8). This station is now staffed 24 hours a day throughout the year to reduce response times as a priority. That resource will join our other staffed 24-hour unit located at our Sicklerville Firehouse (Station 25-7). These units will respond in conjunction with, and alongside



our Volunteer Firefighters. In our organization we have a division known as the Second Responders. While they support many Fire Department activities, they also support community needs such as Holiday Food Drives, Children's gifts for Christmas, hygiene kits for those who experience residential fire loss and many other selfless acts. In 2023 alone, they were able to support approximately 55 families.

We would like to remind everyone to change the batteries in their smoke alarms and carbon monoxide alarms and replace alarms older than 10 years. An operable detector is truly a lifesaver! If you need battery-operated smoke alarms please contact our Fire Marshal's office for more information. Clean your dryer vents on a regular basis, practice home and workplace fire escape drills and be mindful of hazards in the kitchen as well as candle use. We would also like to ask you to keep your address posted and well visible to view from the street to assist us in finding you.

The Fire Department is continuously trying to recruit interested individuals to volunteer and join our team to protect <u>OUR</u> Community. We are in significant need of Volunteer Firefighters as they make up a considerable portion of our organization.

A zoning permit application is required before beginning construction on any new structure on your property. Including, but not limited to replacing a fence or installing a new fence, placing a shed, extending your driveway. A property survey is required as part of this application. A zoning permit is also required before placing animals on any property in Winslow Township per O-2023-021 and Section 82 of the Winslow Township Code.

Winslow Township Planning and Zoning office will have copies of surveys only if work was done in the past that would require such. A new survey can be an added expense to property owners so please check with the Township before hiring a land surveyor.

**VACANT PROPERTIES:** We receive a lot of inquiries about vacant properties and what is permitted on these properties. **Our office always suggests verifying this information before going to closing.** When calling the office—please make sure you have a BLOCK and LOT for vacant properties so we can ensure we give out the correct zoning information.

Property inquiries can also be emailed to: zoning@winslowtownship.com to find out the permitted uses, setback requirements, and any prior approval information that may exist.

## PLANNING AND ZONING BOARD MEETINGS

Winslow Township has several anticipated Development projects that will likely be starting in Spring of 2024. If you notice land clearing, it is likely a part of a **prior approval** that is now getting started. Winslow Township officials work closely with Developers to ensure minimal disruption to the Township residents, however, as with all new construction, trash, debris, and concerns can develop. Winslow Township Zoning Board of Adjustment meets the second Wednesday of the month, beginning at 6:30pm.

## CONSTRUCTION DEPARTMENT

Most outside building projects will require a building and/ or a zoning permit. All swimming pools require zoning and construction permits. You must schedule and pass all final inspections prior to using the pool.

### Electric vehicle charging stations

Just like any other electrical installation, the charging systems for electric vehicles are required to comply with the construction codes adopted by the state of new jersey in the uniform construction code. That doesn't mean a permit is always required, but when it is, the process should be quick and uncomplicated.

Are you a landlord? Please be sure to register your rental property/properties, pay the annual fee and call to schedule the yearly inspection.

BEFORE, DURING and AFTER emergencies, disasters, and other incidents through
Preparedness, Education, Response and Recovery.

## **3 STEPS TO SAFETY:**

- 1. Step One Make an Emergency Supplies Kit (or "go bag").
- 2. Step Two Develop an emergency plan for yourself, your family, and your business.
- 3. **Step Three** Stay informed of possible weather threats.



## **DURING STORMS:**

Helping your family, neighbors, and friends - If someone you know is elderly or dependent upon life-sustaining or health-related equipment such as a ventilator, respirator, or oxygen concentrator, encourage them to be safe during severe winter weather and possible power outages.

- Offer to help them stock an emergency kit including a flashlight and extra batteries, a battery-operated radio, bottled water, nonperishable foods, essential medicines, and extra blankets or sleeping bags.
- Encourage family, neighbors, and friends to develop a list of emergency contact numbers and encourage them to keep it handy. Ask them how you can be most helpful if they needed assistance.
- Check on them after a storm or power outage.

## IF YOU HAVE DISABILITIES OR OTHER SPECIAL NEEDS:

- Register with Winslow's Office of Emergency Management and the Police Department (Non-Emergency Phone # 609-561-3300). Let us know of the assistance you might need during an evacuation or other emergency.
- "Register Ready New Jersey's Special Needs Registry for Disasters" allows NJ residents with disabilities or access and functional needs and their families, friends and associates an opportunity to provide information to emergency response agencies, so emergency responders can better plan to serve them in a disaster or other emergency.



## **IF YOU HAVE PETS:**

- In an emergency, your pet will depend on you for his or her safety and well-being.
- Disaster shelters cannot accept pets other than ADA assistance animals. You must plan accordingly.
- Prepare an "Emergency Supply Kit" for your pet.
- If you must evacuate, there are several pet-friendly hotels in our area who will assist animal owners during an emergency.

## "STAY INFORMED" OF POSSIBLE WEATHER THREATS:

It is important to know about the risks that may happen in our community, and to know whether an emergency is imminent or is already taking place. Contact Winslow's OEM to:

- Ask which types of emergencies are most likely in our area, and how to prepare for each.
- Learn about the warning signals that will be used in your community.
- Learn about the local radio and TV stations you should tune into for emergency alerts and official instructions.

Learn about the disaster plans for your workplace, your children's school or daycare center, and other places where your family spends time.

<u>Keep track of current weather forecasts and alerts with:</u> Local radio or TV stations and/or NOAA Weather radio, NIXLE, and "My Winslow".





Finally, please remember this:

"The first step in emergency preparedness for individuals who may need assistance in a disaster, is to be ready for tomorrow!"

## FROM THE DEPARTMENT OF PUBLIC WORKS

Winslow Township is home to many parks. Please see our website for a full list and what each has to offer. There are three parks that have a walking path and one park, Daniel Calabrese Memorial Park, has a dog park. ## NEW FOR 2024.....Carmelo Felix has a new tot lot

A new tot lot has been installed at Carmelo Felix Park. Using a grant awarded by Camden County the over thirty-year-old tot lot was removed and a new one was installed along with a new swing set and rubber mulch. The new tot lot has slides, climbing areas, an obstacle course and ground level widgets. Carmelo Felix Park is an 8-acre facility with a baseball field, basketball court, walking path and a tot lot located in the center of the Primrose Gate development. It receives heavy use for basketball, parties, baseball and other recreational uses due to its large grassy areas. The tot lot here is very popular due to the park's other facilities and its location.

Spring is a great time to declutter and clean house. Please be reminded of your scheduled bulk day which would depend on your regular trash day. Bulk consists of furniture items, large plastic toys, bathtubs, toilets, and carpet. *No extra bags will be collected for bulk, nor will other trashcans that are filled with debris*. Old regular 32-gallon trash cans that you want to dispose of can go at the curb on your bulk day upside down with an "x" on them. Any glass bulk items would need to be taped with an "x" going across both sides of the glass.

## **Bulk Schedule**

Monday trash day is the first Thursday of the month.

Tuesday trash day is the second Thursday of the month

Wednesday trash day is the third Thursday of the month

Thursday and Friday trash day is the fourth Thursday of the month.

## There is NO pick up if there is a fifth Thursday of any month.

Mattresses/Box springs must be wrapped in plastic to be picked up. Toilets need to be separated in two pieces by unbolting the back. Metal and appliances are scheduled pickups and must be called in or emailed Monday-Thursday for a Friday pick up. No concrete, brick, dirt, top soil, or construction type debris is picked up curb side. For these items you would need to dispose of on your own. Recycle Coach is a great app on our website it reminds you of trash collection, bulk collection, and other important dates.

Electronics can be brought to Public Works during normal business hours. If you are bringing a laptop/computer you can drill a hole in the hard drive to avoid personal information from being obtained from the device. Hazardous Waste would go to one of the Camden County Household Hazardous Waste events please contact them for dates, locations, and any questions pertaining to hazard waste at 856-858-5241. We do accept Motor oil at the Public Works yard. Last year we also started accepting a few additional items in the yard. We now take covered mattresses, furniture, large plastic toys, and clean broken-down cardboard. The yard is available to our township residents during our normal business hours for these items.

## Body Worn Camera Upgrade

The roll out of the police department's new body worn cameras was completed. The newly acquired Axon Body 4's will move the police department toward increased transparency and continue to foster trust and stronger relationships with the community, while at the same time protecting officers from false allegations of wrongdoing.

The new body worn cameras were purchased through a State of New Jersey Department of Law and Public Safety - Office of the Attorney General grant with no financial burden on the township and will replace the Axon Body 2 cameras currently used by our officers. These new cameras offer significantly enhanced technology. Specifically, they offer a wider field of view, increased battery life,



faster charging, improved security and storage and GPS capabilities which greatly increases officer safety and accountability. ## Smart Meter Program

South Jersey Gas (SJG) is working to continually improve the natural gas system that brings safe, reliable, affordable natural gas to our customers. The SJG Smart Meter Program is the next step. Smart Meters will be installed throughout our service area.

## What is the SJG Smart Meter Program?

The SJG Smart Meter Program is a technology upgrade that is added to your gas meter to communicate your meter reading information directly to SJG without the need for a meter reader to visit your property. Smart Meters are connected to an independent and secure wireless network that transfers natural gas usage information directly to SJG. Only natural gas usage information is transferred. No private information is transferred and usage information is not shared outside of SJG.

### What are the benefits of a Smart Meter?

- Improved Meter Reading Accuracy Gas usage is automatically reported from your meter to our customer information system, eliminating the need to have meter readers visit your property to do a manual reading.
- Enhanced Customer Experience Better, faster information helps us improve your experience.
- Increased Reliability Smart Meter data helps SJG better forecast your gas needs to ensure greater reliability for you.

### What you can expect

- On the day of your Smart Meter installation, a South Jersey Gas contractor will knock on your door as a courtesy to let you know they will be upgrading the meter. You do not need to be present for the installation. Contractors will have identification so if you're unsure, ask for ID.
- Installations will take place Monday through Friday, between 7:00 a.m. and 5:00 p.m. Some Saturday work during the same time frame may occur. You do not need to be present for the installation.
- The process will take approximately 60 minutes or less to complete.
- No action is needed on your part, and, in most cases, there will be no service interruption during installation. You will not have to schedule an appointment and you do not need to be present during the installation.
- Once the installation is complete, the contractor will leave a door hanger letting you know the upgrade has been done. If we are unable to complete the installation, a door hanger will be left to provide a number for you to call for an appointment.
